**Parental / Legal Guardian Consent**

I, \_\_\_\_\_ the undersigned, parent/legal guardian of \_\_\_\_\_, a minor, hereby give my consent for this minor to participate in skateboarding, BMX biking, or inline skating at DeKalb County's Brook Run Skate Park. Also, I, the parent or guardian, and I, the undersigned skater / skateboarder / BMX biker, acknowledge, agree and understand that:

1. The undersigned parent / guardian and minor skater / skateboarder / BMX biker recognize the risks and dangers inherent in skateboarding, BMX biking, and inline skating; have examined the Skate Park arena personally; and represent that the skater / skateboarder / BMX biker is capable of using this arena for the purpose for which it is intended, that is, as a venue for skateboarding, BMX biking and inline skating.
2. The undersigned, by signing this form, releases DeKalb County, its officers and employees, from any liability as to any injury which may be suffered by the minor / skater / skateboarder / BMX biker while using the Skate Park, and assumes all risk in connection with the use of the Skate Park. The undersigned indemnifies and holds harmless DeKalb County from liability for any injuries the minor skater / skateboarder / BMX biker may suffer or may cause to another participant.
3. The undersigned and minor skater / skateboarder / BMX biker agree to be bound by and to follow all rules and regulations of the DeKalb County Parks and Recreation Department pertaining to the Brook Run Skate Park, as stated below. It is understood that violation of these rules may result in the suspension or termination of the privilege to use the Brook Run Skate Park.

4. This Consent Form will remain in effect until the suspension or termination of privileges by the DeKalb County Parks and Recreation Department for violation of rules and regulations, or revoked in writing by the Parent or Guardian, or upon the minor's attaining majority on the eighteenth birthday, whichever shall occur first.
5. In the event that the minor should be injured, I, the minors parent or guardian, authorize the DeKalb County Parks and Recreation Department and its officers and employees to take whatever steps may be indicated in their judgment and discretion to provide first aid and to seek medical attention for him or her where in their judgment such is needed, and in exchange I agree to indemnify them and hold them harmless from any good faith decisions on their part, both on behalf of myself and of the minor.
6. DeKalb County reserves the right to close the facility or limit the number of persons admitted at any given time, without refund of any user fee which may be charged.
7. Skate Park Rules and Responsibility Code:
  - All patrons must complete a signed waiver in order to enter and skate in the park. All patrons under the age of 18 years of age must have the waiver signed by a parent or legal guardian. All (youth) waivers must be signed in the presence of the Skate Park staff.
  - **CHILDREN 11 AND UNDER MUST BE ACCOMPANIED BY AN ADULT.**
  - Stay in control. Maintain proper awareness and control of speed. Do not impede or collide with others. Always skate with the flow of other skaters. Be courteous to others.
  - Wear safety gear. **HELMETS ARE MANDATORY.** Elbow and knee pads are recommended. Shirts and shoes are required.
  - Do not place, drop or throw any object in the path of a patron or on the surface of the Skate Park.
  - Alcohol, tobacco and drug use is prohibited in the Skate Park.
  - No Scooters or Heelies <sup>TM</sup>.
  - Food and beverages are allowed only in the concession area. No glass containers.
  - **NO BOOM BOXES.**
  - No pass out.
  - No metal pegs are allowed on BMX bikes.
  - No weapons or animals are allowed in the park.

We, the undersigned parent / guardian and skater / skateboarder / BMX biker acknowledge that we understand and agree to be bound by the above provisions.
